

## **CHAIRMAN'S REPORT**

I am pleased to report that the interest in rugby league has never been greater than it is at present. Not only have the Raiders excited the rugby league community but the total participation in the region continues to break records. In 2025, the CRRL had over 7000 participants for the first time and more than 2000 females participated in our game for the first time.

These are outstanding numbers and is a credit to all our clubs, their volunteers and supporters in providing a product that boys and girls, women and men all wish to participate in as well as consume at the highest level.

The Player Development Framework has been successful in introducing children to a game that concentrates on skills and participation, and the tackle ready program sets up players for a more enjoyable experience.

The success of the wheelchair program at performance level continued. The Canberra Region participated in the inaugural national carnival, and we were pleased to clinch the title undefeated with the team led by three of our original members and Rolling Raiders champions, Toby Popple as captain, Zac Carl and Chris O'Brien.

Again, we thank the continued support of Zatoma Transport and Player 2 in partnering the wheelchair program.

The CRRL is fortunate to have the continued support of Blumers Lawyers as the competition's major sponsor. Mark Blumer and Ian Burchell continue to support rugby league and have always had a great interest in the development of female rugby league. We thank them for their support.

The Raiders Group of clubs and the Canberra District Rugby League continue to support both junior and senior clubs, as well as the administration program undertaken by the CRRL. This support provides the CRRL with the funding to support one of the most professional group of administrators in the state and professionally run competitions. The support from the Raiders Group directly reduces cost for junior participants and clubs through covering fees for the referees and ground hire on Friday nights.



Our thanks go to the Boards and General Managers of Raiders Gungahlin, Raiders Belconnen, Raiders Weston, The Mawson Club and Queanbeyan Leagues Club for their continued support.

This season we also welcomed more partners to the rugby league family. Tradelink, Signworld, Code Security and Jim's Mowing have all partnered with the CRRL in multi-year deals that assist the CRRL in providing the administrative assistance necessary to the clubs in running a growing competition.

The NSWRL instituted a new Judiciary Offences Schedule this season and it was seemingly well received as being a simpler method of operation than the previous points system.

The senior reporting system continues to operate efficiently and overall, the CRRL is pleased with the on-field behaviour as players are cognisant of their responsibilities to their fellow players.

A few areas for improvement which disappointingly became more common during the season were homophobic comments, alleged racial vilification and ableist comments. These are unacceptable and will not be tolerated by either the referees or the CRRL.

The CRRL and the NSWRL had two historic incidents to deal with this season. In both cases the co-operation between the NSWRL, the CRRL and NRL Integrity worked constructively to get an appropriate outcome through the NRL Code of Conduct and NSWRL Code of Conduct. One issue was resolved in 2024 with a lifetime ban and a removal of Life membership, whilst the more current issue was an occurrence in 2024 that necessitated action when the person attempted to be re-registered in the sport, then a complaint was made by the victim which resulted in the blocking of the request.

The CRRL will always act in accordance with its processes and utilising the availability of both the NRL and NSWRL where necessary and its own independent judiciary and disciplinary system where required to uphold the integrity of the CRRL and protect its members.

The CRRL Judiciary continued to partner with the NSWRL, in hearing cases for Group 20, Group 16, Group 9 (as applicable), taking on the Sydney overflow when asked and Touch Football ACT, whilst continuing to contribute to the overall system's development. We extend our gratitude to Co-Chairs Chris Gribble, Bwalya Chifuntwe, and Sarah Rodrigues, Appeals Chair Jonathan Hanton, and the entire Judiciary panel, including Geoff Milczuk, Phil Stuart, Danny Roper, John Cooper, Papunya Connors, Rob Scott, and Bernard Powderly. Glyn Sargent, Head of the Match Review Committee, who was joined this season by Mark Ryan in assessing the weekend's incidents which were over 250 for the league.

NSWRL has continued its commitment to the Bruce facility (affectionately known as Shark Park) and is seeking to extend its lease and invest in the facility once the final decision has been made about a new stadium. Currently there is a grant application in with the ACT Government for a lights upgrade to which the NSWRL through their grant program has contributed, Belconnen Sharks and the CRRL will also contribute.

To NSWRL CEO Dave Trodden, CFO Dean Webster, Community Manager Peter Clarke, Facilities Manager Ben Jessimar, Regional Manager Dave Skinner, and Monaro representative Jake McDonald, thank you for your continued assistance, advice and partnering in projects with the CRRL.

## GENERAL MANAGER'S REPORT

The 2025 season was another one of growth for the CRRL.

The Snapshot:

- Overall participation grew from 6520 to 7108.
- This was an increase in participation of 9.02% - up from 6.13% in 2024.
- An increase in male participation of 5.93% - up from 4.4% in 2024.
- An increase in female participation of 17.6% - up from 13.75% in 2024.
- Retention rates increased from 74% in 2024 to 79% in 2025.
- Male retention rate went from 76% to 80%.
- Female retention rate went from 68% to 77%.
- Media engagement continued to grow - Facebook 17401 to 18936, Instagram 5196 to 7078, X (Twitter) 618 to 646.
- BAR TV grew from 227,713 to 391,259 views an increase 71% views.
- CRRL remained the 4<sup>th</sup> largest rugby league region in the NSWRL.
- The Canberra Region Rolling State team won the National Championships
- The George Tooke Shield representative teams won the Men's, League Tag and Under 18 matches against the Woodbridge Cup representative teams.
- Jon Tucker, Carrie Jackson and Jayden Grocott were recognised for their contributions to rugby league.




Figure 4 CRRL Participation Numbers 2015-2025



## **Facilities**

The ovals showed a marked improvement in the 2025 season as the ACT Sportsgrounds regimen reacted to the poor conditions that ovals were in during 2024. This was a gratifying improvement for players through all grades.

There was progress in several areas around facilities during the 2025 season.

The Phillip District Enclosed Oval redevelopment saw the new pavilion completed and opened as stage one of the works. The new facilities have been greatly appreciated by the Woden club and junior finals were able to return to the venue in 2025. In 2026 we look forward to having the total project completed with the ground re-alignment, new irrigation and drainage and lights installed.

The ACT Government has commenced its consultation around the Taylor Development with a pavilion and two new synthetic fields to be added to the existing two grass ovals currently in use. The ability for the Gungahlin club to relocate there in its entirety is getting closer. Ideally, the last two grass fields will hopefully also be completed in the near future.

The ACT Government has reacted to the need for Melba to be extended, to be able to cope with the dramatic growth in the Belconnen Sharks juniors club participation numbers. A plan to bring back some of the Millenium drought closed grounds will be very much appreciated not only by the club but also the ground itself!

Seiffert Oval received two extra dressing rooms which now gives the facility the ability to host multiple games on game day and it allows for a coordinated approach in a five-game day.

The Kangaroos were confirmed with grants to build a new pavilion for the lower grounds at Freebody Oval which will enhance that facility.

The Stromlo facility has gone to the Development Application stage with the Government and will be a welcome addition to a growing area when completed.

The uncertainty around the Bruce facility due to the ACT Government's due diligence on where it is best to place a new stadium is problematic for both the Belconnen Sharks and the NSWRL. NSWRL in fact wishes to invest in the facility and announced a \$30,000 grant to the Sharks should the facility not be considered for a major stadium.



NSWRL have employed Daniel Ristic as the new Facilities Strategist, and we look forward to working with Daniel in delivering the complete facilities audit for the region which will assist in planning and grants into the future.

### Participation & Retention Statistics

The continued growth in participation across all ages, especially in the juniors, is a pleasing aspect of the statistics that we see illustrated in the accompanying graphs.

The Player Development Framework which incorporated the Tackle Ready program saw the 3-7 age group bounce from 880 to 1036 participants.

The 13 to 15 age grouping saw a rise from 1324 participants to 1541. This was significant especially as it is in a key age demographic. The Under 8-9 and Under 10-12 grouping were both up but by smaller margins. Whilst the growth of League Tag has been important in bringing more girls to the game, with the boys numbers also rising.

The increase in the retention rates is a very pleasing aspect of the delivery of rugby league. As is commonly known it is far easier to retain children engaged in the game rather than always having to find new recruits. The increase in the retention rates is a credit to clubs who have worked hard on creating positive environments and good experiences for players which encourages their return. The fact that both the male and female retention rates are up significantly shows a consistency of approach that is having positive outcomes.

We need to consolidate the great work in the retention space and look to the next frontiers being the recruitment of more female coaches and referees.

The growth in the numbers has placed a strain on the refereeing ranks and as a sport we need to recruit more referees but through positive behaviour help retain our referees.



## **Trainers and First Aid**

Rugby league continues to lead sports at community level for the care and welfare of players through its accreditation system of sports trainers and first aid. This cohort is the secret sauce to the on-going longevity of the game in giving parents and players confidence that the game of rugby league will look after its own people. We all know that we play a contact sport but the system of accredited people on the sideline being a positive first responder is a sport that recognises the health and well-being of its players.

Concussion remains one of the biggest on-going challenges to our game but with the right protocols in place, supported by our trainers and the rugby league community, we can mitigate the harshest aspects of our game.

That said, the CRRL will continue to work with experts in better understanding concussion and ensuring best practice is maintained.

## **Coach Developer**

The single biggest change to the CRRL approach to rugby league in the region this year was the employment of the region's first Coach Developer. Liam Herbert was employed in the role to service all coaches throughout the region, with a focus on junior coaches.

The role is a joint initiative between the ACT Government Industry Partnership Program, the CDRL and CRRL. The idea behind the program was to assist and improve the level of coaching at junior level to make training and playing a better experience for players in the hope that with a positive experience, they would return to the sport the following season. This also applies to coaches who do a fantastic job in their volunteer role but

often feel they do not have the support or the resources to improve their coaching.

Allied to this, a coach can influence so many other areas such as team culture, parental behaviour and acting appropriately on the sidelines thereby modelling positive behaviour for all. Coaches that are well equipped also respect the referee and the positive interchange between referees and coaches can assist in keeping referees.

The first year has been one of rolling out the program but we see very positive results in the initial stages of this role.



## Competitions

The CRRL staff, the referees and its club volunteers have the herculean task of organising and delivering approximately 230 games each weekend across 39 venues from areas as wide as Harden in the northwest to Goulburn further east, down to Jindabyne in the south and the greater Canberra region.

Once again all have risen to the occasion by running one of the most professional leagues in the NSWRL and maintains its reputation as a can-do area.

Two significant areas of development in the juniors have been the last Under 12 Grand Final and the establishment of the Junior Bushrangers.

With the implementation of the Player Development Framework (PDF), the transition to a non-competition mode up to and including Under 12s is now complete. From 2026 Finals series will only be played from Under 13 upwards. Whilst there had been a large amount of debate that players would leave the game without a finals series, the statistics do not currently support this. In fact, rugby league has simply caught up to where many of the other sports have already moved.

The Junior Bushrangers is an initiative in bringing the three Tuggeranong based junior clubs (Tuggeranong Buffaloes, Valley Dragons, South Tuggeranong Knights) together from the international grades and with female teams to provide an integrated pathway to their senior Tuggeranong Bushrangers club. An MOU has been in place with the clubs, and this pilot has continued to progress. The pilot has especially supported the growth in female participation in the Valley as the numbers have built on many terrific school gala days held by NRL Development. Congratulations to Jason Hall on driving this initiative.

The other development in the junior space is the establishment of the rugby league hubs for the younger players. The Cooma hub was established to ensure the younger age groups (Under 6, 7, 8,9 & league tag) did not have to travel as far and began re-introducing junior rugby league to places like Jindabyne. This method increased participation by over 100 across age groups.

Goulburn/Crookwell also have a well-established hub and the CRRL is looking to expand this program in other regional areas.

The Canberra Raiders Cup Grand Finals had the unique experience of being moved just a few weeks out to accommodate the Canberra Raiders vs Brisbane Broncos Semi Final being played at GIO on the Sunday of what would've been Raiders Cup Grand Final day.



Everything was accommodated and we thank the clubs here for their co-operation. In fact, the move to a Saturday Grand Final has seen the clubs vote for that to be maintained into 2026.

The bulk of the Raiders Cup clubs were able to field all five teams which showed the strength of both the male and female participation at senior level. However, there are challenges in pockets such as Queanbeyan where the Blues had to forfeit two Reserve Grade matches and folded their Katrina Fanning Shield (KFS) team mid-season. The Queanbeyan Kangaroos have also been light in Reserve Grade, did not field an Under 19s nor League tag team and despite their best efforts could not increase their KFS numbers above 11 and so ultimately folded the team.

These events drew media scrutiny, but the CRRL believes that there are some structural changes required with the clubs, which they are undertaking along with the necessity of a closer relationship with the juniors as applicable.

The George Tooke Shield took on a different look this season with Cootamundra returning to Group 9 having rebuilt, so the George Tooke Shield (GTS) competition has again assisted a club in reviving itself. This season we welcomed a completely new club in Googong, who were able to field a men's tackle and League Tag team plus the legendary Snowy River Bears, switching from Group 16. Both were welcome additions to the competition.

This season there was virtually a GTS Match of the Round covered on BAR TV with participating clubs receiving three matches in general whether home or away. This initiative increased the exposure of the competition markedly where the Round 1 Crookwell v Bungendore League tag match was our third highest viewed game of the season including Raiders Cup coverage.

The growth in BAR TV viewership has been impressive. Apart from the growth in total views from 227,713 in 2024 to 391,259 in 2025 we saw total users grow from 23,046 to 29,100 and sessions also increased from 82,075 to 117,105. Impressive engagement from our supporters watching community rugby league.

The highlight this year for the Wheelchair Rugby League was the win at the National Championships for the Canberra Region team. Headed by our long serving players Toby Popple, Zac Carl and Chris O'Brien, the team picked up extra players and then powered to an unbeaten run in the carnival accounting for NSW in the final.

The Rolling Raiders had been unable to defend their title in the NSW Wheelchair Cup but finished a creditable 3<sup>rd</sup>.

An addition to the calendar this year was the June Long Weekend League Tag carnival which acted as a prelude to the state championships in September. This competition, held at Nicholls this year in tough weather conditions, featured Open and Under 16 teams from Canberra, Group 16, Group 9 and Group 20. We



envisage this carnival growing to 2 days in coming years and expanding into a major event.

At the state carnival held in September at St Mary's both the Open and Under 16 qualified for the Semi Finals, with the Open team making the Grand Final. Despite both teams not claiming victory the strength of league tag in Canberra is being maintained on an upward trajectory. Our thanks to coaches Darren Grocott and Taylor Giggins and their respective teams for your input in developing the League Tag strategy.

The magic round concept for the 14- and 15-year-old boys was maintained as part of the youth pathways identification, and this was added to with the introduction of the Under 15 girls magic round.

There was more exposure this year for players as several Friday night junior matches in the Under 16 and Under 17 tackle and tag competitions were covered by BAR TV giving people a chance to see junior rugby league from the comfort of their homes.

One major change for 2026 will see the NSWRL using Howdens as their insurance broker switching from long term partner Gallaghers. We are yet to see what effect this will have on premiums, if any.

## **Referees**

The growth of the CRRL in participation in recent seasons has placed ever greater pressure on our referees and the Referees' Association in relation to recruitment and retention. The increase from about 170 to 230 games a weekend places enormous pressure on appointments where we continue to have match officials doing matches on Friday, Saturday and Sunday. This is somewhat unsustainable without assistance going into the future.

Apart from a general call for more people to "take up the whistle" we also need our supporters on the sideline to be fully aware of their role in encouraging young referees and the impact of negative comments on them staying in the game.

The CRRL wishes to commend the work of the Referees Executive with Oliver Levido in the Chair and especially its coaching team led by Matt Hall who have taken the assessment and feedback to another level.

We farewelled Anthony McQueen from the organisation and thank him for his work in the Accreditation and Inclusion areas. Anthony was especially effective in the Wheelchair rugby league space guiding the Rolling Raiders to their initial NSW Cup victory. have been more than happy to assist Taylor at her well-organised gala days to ensure smooth and professional delivery of events that can help boost participation numbers for clubs.

Jess Crisp, as Community Manager, ties the NRL and CRRL community aspects of the business together, the organisation of game day events at GIO and assisting the CRRL staff and clubs in delivering mini footy, the club relay race, the mascots involvement and liaising as required makes her an invaluable part of the team. Jess also completed the Reconciliation Action Plan across the business and developed the club's statement of principles regarding our indigenous commitment.

The success of the Raiders NRL team, the establishment of the NRLW Raiders and the drive from the CRRL clubs and staff sees rugby league in a healthy place at present. However, we will be exploring gaps in the market to see if we can have more people involved actively playing the game. We will look to better service players, referees, coaches and volunteers to ensure that rugby league is providing a sport that all can be involved in.

The CRRL takes its responsibility to servicing our local community but also the wider regional community to maintain its reputation as an organisation that is inclusive, progressive, innovative and challenges the status quo.




Figure 13 CRRL Junior Participation Numbers




Figure 14 Male Junior Participation




Figure 15 Male Junior Participation by club




Figure 16 Female Junior Participation Numbers




Figure 17 Female Junior Participation by Club

## **NAMING OF AWARDS**

**Les McIntyre Medal** – The Canberra Raiders Cup First Grade Best and Fairest Award is named after Les McIntyre OAM who was the founding father of the Canberra Raiders. McIntyre was awarded life membership at the Canberra Raiders, Country Rugby League, and New South Wales Rugby League.

**Don Furner Snr Shield** – The Canberra Raiders Cup First Grade Coach of the Year award is named after former Australian representative Don Furner Senior. During his playing years, Furner also represented Queensland before enjoying a successful coaching career. Furner coached Australia, the Queanbeyan Blues, and was also the inaugural coach of the Canberra Raiders.

**Leedon Shield** – The Canberra Raiders Cup Reserve Grade Best and Fairest award is named after Lee Donnelly who helped pave the way for the Raiders' entry to the NSWRL competition in 1982. He was heavily involved with the Woden Valley Rams and was also awarded life membership of the old Group 19 competition.

**David Sharpe Award** – The Canberra Raiders Cup Under 19's Best and Fairest Award is named after David Sharpe. Sharpe was involved in rugby league in the Canberra Region as a player for the Queanbeyan Blues before helping establish senior rugby league in Tuggeranong with the Valley Dragons and Tuggeranong Bushrangers. Sharpe coached both sides. He was well known for his role as football manager with the Canberra Raiders where he implemented education, development, and welfare programs for the NRL.



**Gavin Miller Shield** – The George Tooke Shield Open Men's Best and Fairest Award is named after two-time Dally M Medalist Gavin Miller. Miller played for a number of clubs but is best remembered for his stint at Cronulla where he was named as a club immortal. Miller also played for Goulburn during the late 1970's and early 1990's.

**Sarah Carter Medal** – The Canberra Raiders Cup League Tag Best and Fairest Award is named after one of the original players of the competition, Sarah Carter. Carter joined the competition at its inception in 2016, initially representing the Belconnen United Sharks. She went on to play for the West Belconnen Warriors from 2018-2022 where she was named Player of the Year in both 2019 and 2022 and is a three-time leading point scorer.

**Emma James Medal** – The George Tooke Shield League Tag Best and Fairest Award is named after Emma James. James is a long-standing Harden Hawkettes team member and has been instrumental in their success, earning five Best and Fairest awards and winning six premierships.

**Hewson/Stonham Shield** – The Representative Player of the Year Award is named after Steve Hewson and Phil Stonham. Steve Hewson, who was awarded an Order of Australia in 2023, represented Monaro, NSW Country, NSW, and was named Country Player of the Year in 1975. He is now involved in developing the overall strategy for NSW Wheelchair Rugby League, and in previous years has coached the Wheelaroos and NSW Wheelchair State of Origin teams. Phil Stonham enjoyed a long representative career with Monaro and was named Canberra Region as well as Country Player of the Year in 2004. Stonham played for the Queanbeyan Blues throughout most of his playing career.



**Noel Bissett Trophy** – The Outstanding Referee Award is named after former NSWRL referee and former CRRL Chairman, Noel Bissett. Bissett, who was awarded an Order of Australia in 2013, officiated in 275 Group 8 matches including 11 Grand Finals. Bissett is a life member of the Canberra Raiders and was also the president of the Canberra/Monaro Men of League charity.

**Don Elphick Medal** – The award for a Rookie from the Canberra Region and the Canberra Raiders that debuted in the NRL side is named after Don Elphick. Elphick played an instrumental role in the formation of the Canberra Raiders and is a life member of the club.

**Ahlivia Ingram Medal** – The award for a Rookie from the Canberra Region and the Canberra Raiders that debuted in the NRLW side is named after Ahlivia Ingram. Ingram was an inaugural squad member of the NRLW team and played her junior Rugby League at the Valley Dragons.

The 2025 Blumers Lawyers Canberra Raiders Cup First Grade season ended with the Queanbeyan Blues denying their cross town rivals in the Queanbeyan Kangaroos of an historic three-peat in dramatic fashion at Seiffert Oval.

The season was highly competitive, especially among the top four teams, all of which were strong contenders for the title as finals approached.

The Kangaroos secured their third consecutive Minor Premiership, finishing ahead of the Blues, whilst the Warriors and Bushrangers both finished on 20 points, with the for and against of West Belconnen seeing them host the elimination final.

After a closely contested semi-finals series, the Queanbeyan rivals faced off in the Grand Final, for the second consecutive year.

Unlike last year, the Blues had the wood over the Kangaroos this season claiming victory twice in the regular season, before booking their Grand Final spot with a 28-16 win.

In the Grand Final, the Kangaroos were on the cusp of securing the three-peat, leading by eight with ten minutes remaining, before Dylan McLachlan guided his side to victory and in the process etching his name in Canberra Raiders Cup history, the Blues winning the decider 28-26.

## ACCREDITATION REPORT

Building on the success of our accreditation compliance in 2024, the 2025 season proved to be another outstanding year for CRRL. Thanks to the dedication of our accredited volunteers, both the Junior and Senior competitions continued to thrive.

As in previous seasons, we encountered challenges, but the ongoing communication and strong relationships between CRRL and our clubs enabled these to be addressed effectively. This included:

- League First Aid & Sports Trainer Courses: Eight courses

## **INCLUSION PROGRAMS REPORT**

2025 was another outstanding year for Canberra Region Rugby League's inclusion programs, with both the Rolling Raiders and Score Raiders continuing to grow, engage, and inspire. These programs have further cemented their place as vital pillars of community rugby league, offering people of all abilities the opportunity to participate, develop their skills, and enjoy the sport in a safe, inclusive, and welcoming environment.

The Wheelchair Rugby League program enjoyed a busy and rewarding calendar of events, designed to promote inclusion, skill development, and community participation. Highlights included a series of school-based clinics introducing students to the fundamentals of wheelchair rugby league, the Schools Gala Day which brought together students from across the region for a fun and competitive experience, and an interschool gala day hosted at Monaro High School. Participants also took part in a wheelchair rugby activation at the Maccas Masterclass, giving attendees a hands-on and interactive taste of the game. Further activations at several Canberra Raiders NRL matches allowed fans of all ages and abilities to experience the sport firsthand.

A major milestone this year was Canberra Region Rugby League's debut in the NRL Wheelchair Championships on the Gold Coast, marking the first time an ACT team has competed at this national event. The ACT team's outstanding performance saw them go undefeated and crowned national champions, an historic achievement that highlights the depth of local talent and represents a significant step forward for wheelchair rugby league in both the ACT and Australia.

## **COACH DEVELOPER REPORT**

The coach developer role has been incredibly well received around the junior rugby league community, with it being a fantastic experience for myself and the hard-working volunteer coaches. The opportunity to visit local coaches and build relationships has not only created the foundations for this role in years to come but has allowed me to really understand where each coach needs support.

One instrument I have introduced to help refine where support is needed is the simple yet highly effective traffic light system. This is a way for coaches to be measured regarding whether they are suitable for the role, and what level of support they need from myself or the club moving forward.

This tool was used to observe coaches both on match days and during training sessions. Coaches were not told on match days if I would be in attendance, so that a genuine assessment could be made. However, coaches were always notified upon a training visit from myself, so they could use the resource to the full potential and ask for help.

In 2025, I was quite happy with the behaviour across the board of our junior coaches. The coaching template which was created in collaboration with each club gave coaches a clear understanding around the minimum expectations throughout the season. Transparent guidelines such as coaching the fundamentals, teaching life skills, prioritising inclusion and fun, were all driven by clubs and myself to ensure that coaches were understanding of what is acceptable. Along with the coaching template, other resources were created and facilitated such as the CRRL coach education website, the coaches corner group chat, and in-person workshops to help provide further support and options for coaches to learn about ways to give our junior players the best experience possible.

After reflecting on 2025 and moving into 2026, learnings and areas have been identified for more specific resources to be added and provided into the coming season. The first key focus for myself in 2026 will be working with and providing a clear outline of duties for our coaching coordinators to execute throughout the season. The aim is for coaching coordinators to provide more frequent face-to-face support to club coaches. This will allow coaches to receive the correct and regular support needed to thrive throughout the season, rather than waiting for



the occasional visit from the coach developer. Coaching coordinators will also have increased communication with myself, to ensure I am up to date with which specific coaches that need more attention, but also to provide the correct advice, tools and resources to coaching coordinators, to be proactive and provide necessary support for local coaches to excel.

Coaching manuals have also been developed and will be rolled out to every coach within the region. This will include what is expected from a behavioural and facilitating perspective, as well as rules, guidelines and curriculums for coaches to follow throughout the season.

New workshops such as “Facilitating the fundamentals” and “Mandatory educational sessions” will be rolled out in 2026. This is to ensure that we get the best possible results from our coaches and provides us with the best chance of our players receiving a great experience.

I look forward to building and adding to the coach developer role in 2026 and ensuring that coaching quality is a key factor in making Rugby League a great game for all.

Our annual Raiders Blitz in 2025 saw us reach a massive 38 schools with over 8,500 students reached in one day.

In 2025 we said goodbye and a huge thank you to Game Development Officer Shane Read as he moves into other spaces within Rugby League. NRL Canberra have been lucky to have you over the past number of years, and we wish you well in your future endeavours.

League Stars, our after-school introductory program for Rugby League, saw some big numbers with Term 1 taking us to Cooma to see 48 students mainly from Cooma North Public School. Term 2 saw 9 participants at Charles Conder, and Term 3 was hugely positive with 34 participants from Forrest Primary School. Both the April and July school holidays saw our largely successful Maccas Masterclass clinics alongside the Canberra Raiders sell out with 220 participants each. In October we took our holiday clinic to Crookwell where we saw an impressive 32 participants for some school holiday fun.

Tackle Ready this year was rolled out across 3 venues: Cooma, Goulburn and Canberra. This year the format was updated to a three gala day format with sessions rolled out by Game Development staff and supported by the coaches. We were pleased to watch the confidence and competence of the u7s improve over the 7 weeks of Tackle Ready.

## **REFEREES REPORT**

In 2025 the Canberra Region Rugby League competition increased player participation to become the third largest District in New South Wales. Female participation was again a driver for this increase. This increase saw our Association officiating approximately 235 games of tackle and tag rugby league each weekend. Our members should be congratulated on the professionalism and dedication they showed throughout the season. As usual for Canberra we had quite a few mornings that were very “cold” and a testament to the commitment and dedication of members that they continued to turn up each weekend to officiate.

Recruitment continued to be very strong with Twenty-Nine (29) candidates undertaking the Community Referees U6-U12 Years course. The Association also facilitated Sixty-Eight (68) members of the RISE program as well, with a number already joining our Association. As most are still playing Rugby League, the challenge has been to arrange their match appointments around their games. Our local Referee Development Officer Tim Bailey continued to provide his support in the recruitment, accreditation and education arena.

We are lucky to have organisations such as the Canberra Raiders, Canberra Region Rugby League and NSW Rugby League Referees Association support our Association and provide resources and assistance with recruitment and development of referees. The support from the CRRL staff, especially General Manager Mark Vergano and Chairman Gary Green cannot be under-estimated. Incidents involving unsavory conduct by players, officials or spectators were swiftly dealt with by the League, sending a strong message that poor behaviour is not acceptable and match officials will be supported by them. The assistance provided by Deb Charman and Stacey Studholme cannot be underestimated. The time and effort they put into coordinating the Senior and Junior competitions greatly assists the operations of our Association.

In 2025, Canberra referees rolled out some changes in coaching and development. A change in trainers brought new ideas and a consistent attendance, on average 20 referees attended weekly training, with changes to a new on-field management structure. These changes provide new pieces of education through a weekly coaching note sent out, video coaching clips supplied to referees and a new coaching form.

We saw a lot of referees get a chance to prove themselves in the middle, on the line, with everyone taking the opportunity to learn from it and improve.



We unfortunately lost a few games to forfeits but our game did grow in the female arena and has proven to grow year on year.

Our Association held a successful Referee Exchange with Cronulla – 1st Grade Andrew Nightingale, Reserve Grade Jack Black, and U19's Billy Perrott. The feedback was very positive. We have a significant number of Junior referees coming through which will hopefully build a strong base for our Association in 2026.

The most important part of our Association are its members. The game can't be played without referees, and our referees can't do their job without the support they receive from all members within the Association. 2025 saw the introduction of a Director of Welfare which is a welcome addition to the Board and emphasises the Associations commitment to the wellbeing of its members.

The future of our Association relies on the retention and development of new referees. Our junior coordinators and coaches played a key role in supporting our junior referees and did an outstanding job in their development which improves their overall experience and subsequent retention in our Association.

## **JUDICIARY REPORT**

In alignment with the NSWRL there were some changes to the way in which penalties for offences were calculated this year. Previously calculations for offences were points based with discounts available for early pleas and records of good behaviour over several years. This year penalties were moved to matches and the only discount being one match for an early plea regardless of the offence. Rather than loadings for multiple offences within 2 years, a 1st – 4th offence system was introduced, for each subsequent offence the penalty increased

regardless of the offence. This new schedule of penalties did prove expensive for some players with multiple offences within the two-year period.

Of all offences in the season for senior grades, first, reserve and under 19's accounted for over half of all initially charged. In the juniors there were 35 proven offences, a pleasing result given the number of players across the eleven age groups and multiple teams represented in these cohorts.

Striking, Dangerous Contact and Dangerous Throws were the most common offences across all grades. Concerningly three other offences, Offensive Language in general, Offensive Language directed at a match official also appeared strongly across all grades. Homophobic comments were unfortunately very high particularly in the 16 – 19 years cohorts.

The behaviour of spectators, supporters and team officials featured several times at hearings and in missives to clubs. Abuse of match officials and offensive language in general will not be tolerated and will draw significant penalties in the 2026 season.

In response to this the judicial hearing panels are increasingly applying Good Behaviour Bonds as part of their penalty for offences around the above groups. Clubs are again reminded that they are responsible on game day, not only for their teams and officials but also for spectators and supporters. Failure to ensure that adequate responses are made for inappropriate sideline behaviour may lead to further action being taken by the Match Review Committee and the CRRL.

The judicial hearings are heard each Wednesday by an independent panel made up of two panel members and the hearing chairperson. Hearings are often lengthy, and thanks must go to the three chairpersons and the six rotating panel members for their efforts and the volunteering of their time.





## **NEWS FROM 2025**

### **Fresh Faces Join the 2025 George Tooke Shield**



The CRRL is excited to welcome two teams to the 2025 George Tooke Shield (GTS), the Snowy River Bears and the newly established Googong Goannas.

Fresh off their 2024 Group 16 premiership victory, the Snowy River Bears have opted to make the switch to the GTS in 2025.

Meanwhile, the fast-growing Monaro-region town of Googong has formed a rugby league club, with the Googong Goannas RLFC set to compete in the GTS Men's Tackle and Women's League Tag competitions.

With the Cootamundra Bulldogs returning to Group 9, the GTS will feature nine teams in Men's Tackle, while Women's League Tag may expand to nine teams, with Snowy River working to establish a side.

Goannas secretary Tracy Morgan said establishing a rugby league club in Googong had been a long-time ambition.

"Simon Morgan (Goannas president) had done a lot of the groundwork in 2016, but around the COVID epidemic, it was put on hold," Morgan said.

"As a resident of Googong, he noticed there was a need for the town to have its own sporting clubs. Since then, we've seen other codes get up and running and be successful."

Now, the Goannas are making that vision a reality.

"It's really amazing and a little bit surreal," Morgan said.

"Googong has grown so much, and with other sporting clubs having great success, not just on the scoreboards but with the community involvement, we knew it was the right time to try and see what happens."

The Goannas will call Duncan Fields home, a venue that will bring the community together on game days, with strong support already established for the club.



“It’s such a great spot, and we hope it will bring a lot of people down to watch some Saturday footy,” Morgan said.



“We already have a lot of people interested in playing and also in volunteering.

“We’re so appreciative of the support we’ve received from CRRL, sponsors, and the community – we couldn’t have done it alone.”

The CRRL also acknowledges the generosity of Geoff Young, president of the Monaro Panthers Football Club, for his willingness to share the grounds for both soccer and rugby league, further strengthening the close-knit community of Googong.

With a solid foundation and passionate supporters, the Googong Goannas are ready to make their mark on the GTS and contribute to the region’s rugby league future.

Meanwhile, the Snowy River Bears’ move to the GTS comes after a challenging period of trying to field both Firsts and Reserves in Group 16, coupled with the departure of several key players.

“We have been struggling to fill two grades for the past few years, and many of our First Grade players have moved on to other clubs or competitions after winning the Group 16 premiership,” club president Jason Dyball said.



“As such, we would have been unable to continue within Group 16, and there was potential that our club may have had to fold.”

The switch to the GTS provides a fresh start, allowing the Bears to field just one team and focus on developing young local talent.

“Moving to the GTS will benefit our club by allowing us to focus on a single team and most of all, will allow us to develop our local younger players into quality footballers through mentorship from some of our more seasoned veterans,” Dyball said.

The Bears have brief history in the GTS, having competed in the 1997 and 1998 seasons. Now, more than two decades later, their return marks an exciting new chapter for the club.

Their inclusion also supports CRRL’s efforts to develop a hub for junior rugby league in the Snowy Monaro Region, covering Cooma, Jindabyne, Bombala, and surrounding areas.

## **OBITUARIES**

### **Ian Baker**

The CRRL is deeply saddened to learn of the passing of Queanbeyan Kangaroos club legend, Ian Baker.

A lifelong contributor to the Kangaroos since their inception in 1969, Ian most recently served as club president from 2020 to 2023, continuing a remarkable legacy of dedication and leadership.

Ian was one of the club's foundation junior players, inspiring his younger brothers - David, Neil, Michael, and Ashley - to also don the Kangaroos jersey. He went on to play over 100 first grade games, winning two premierships and becoming the inaugural recipient of the prestigious Les McIntyre Medal in 1987, awarded to the competition's best and fairest.



Ian's involvement extended well beyond his playing days, serving as a long-time trainer for the Kangaroos and continuing to support the club in various roles across decades.

Ian's passion for the club was shared by his family. His mother, Barbra Baker, played a pivotal role in her sons' rugby league journeys, serving as Committee Member and Secretary for both the Junior and Senior Kangaroos for many years. In recent times, Barbra and her husband, Gordon Baker - Ian's father - continued to support the club as dedicated volunteers in the Freebody Oval canteen.

As club president, Ian made culture a priority. That legacy was reflected in the club's 10-year drought-breaking premiership win in 2023 and again in 2024 under new president Troy Whiley, who stepped in while Ian bravely battled cancer. Together, these back-to-back premierships stand as a testament to Ian's influence.

Ian Baker leaves behind a lasting legacy at the Queanbeyan Kangaroos and within the broader rugby league community. He will be sorely missed, and the CRRL extends its heartfelt condolences to the Baker family.



### **Bobby Warner**



The CRRL is deeply saddened to learn of the passing of Queanbeyan Blues club legend, Bobby Warner.

As a life member of the Queanbeyan Blues, Bobby dedicated over 50 years of service to the club.

Throughout his time with the Blues, Warner held many roles on the executive

at both the senior and junior clubs, with 30 years of his service dedicated to the role of president within the junior club.

"It is with sadness that we have lost another of the history of the CRRL with the passing of Queanbeyan Blues and early Raiders stalwart Bobby Warner," CRRL Chairman Gary Green said.

"It is only fitting that his memory will live on with the recent naming of the Bobby Warner Pavillion at Wright Park."

The Queanbeyan Blues will commemorate Bobby's legacy by holding a minute silence at this weekend's senior games and wearing black armbands at junior games.

### **Percy Knight**

The Canberra Raiders are saddened by the passing of Raider #39, Percy Knight.

Originally from Condobolin, NSW, Percy Knight played 24 matches for the Raiders from 1983 to 1984, after joining the club from Balmain, where he played 64 matches from 1978 to 1982.

He was also part of the famous Monaro side of 1977, which defeated the touring Great Britain Lions 33-12 in a match held at Seiffert Oval.



Canberra Raiders Patron and former Chairman John McIntyre said Knight was one of the first players the club targeted when it entered the competition in 1982.

“Percy was one of a number of players we listed in the official submission to the NSWRL as possible players we would target if we were to gain entry to the competition,” Mr McIntyre said.

“We weren’t able to sign him initially, though, as he re-signed with Balmain, but eventually he joined the Raiders alongside a number of former Balmain players like Lloyd Martin, Gary Spears, Alan McMahon, and of course, David Grant.”

Mr McIntyre said Percy Knight was a player who always gave his best when playing for the Raiders and was one of the smartest players of his time.

“He was a great organiser for our team at the time, and not only was he a very intelligent man on the field, he was also very intelligent off it.”



### **Paul Robertson**

After moving to Canberra in the early 1990s, Paul Robertson was an integral member of the Tuggeranong Rugby League community, coaching his sons Michael, Adam and Brad at the Buffaloes and Dragons.

**Corporate Information**

The financial statements cover Canberra Region Junior Rugby League Incorporated (the Association) as an individual not-for-profit entity. Canberra Region Junior Rugby League Incorporated is an association incorporated in the ACT under the *Associations Incorporation Act 1991 (ACT)*.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in financial statements containing relevant and reliable information about transactions, events and conditions. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless otherwise stated.

**Note 1. Statement of Material Accounting Policy Information**

**Basis of Preparation**

The financial statements are general purpose financial statements that have been prepared in accordance with *Australian Accounting Standards - Simplified Disclosures of the Australian Accounting Standards Board*, and the *Association Incorporation Act 1991 (ACT)*.

The financial statements have been prepared on an accruals basis and are based on historical costs.

The financial statements are presented in Australian dollars and all values are rounded to the nearest dollar unless otherwise stated.

The financial statements were authorised for issue on 10th December 2025 by the Committee.

The financial statements have been prepared on a going concern basis. With the agreement that Canberra District Rugby League Football Club Limited will continue to provide financial support as disclosed in Note 9, the Association will be able to pay its debts as and when they fall due.

**Accounting Policies**

**a) Income Tax**

The Association is exempt from income tax under Section 50-45 of the *Income Tax Assessment Act 1997*.

**b) Inventories**

Inventories are measured at the lower of cost and net realisable value.

**c) Plant and Equipment**

Each class of plant and equipment is carried at cost less, where applicable, any accumulated depreciation and any impairment losses.

In the event the carrying amount of plant and equipment is greater than its estimated recoverable amount, the carrying amount is written down immediately to its estimated recoverable amount and impairment losses recognised in the statement of comprehensive income.

**Depreciation**

Plant and equipment are depreciated on either a straight line basis or diminishing value basis over the asset's useful life commencing from the time the asset is held ready for use.

The depreciation rates used for each class of depreciable assets are:

<b>Class of fixed asset</b>	<b>Depreciation rate</b>
Plant & Equipment	10% - 50%

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains and losses are included in the statement of comprehensive income.

**d) Financial Instruments**

The Association's financial instruments comprise cash and cash equivalents, trade and other receivables and trade and other payables and are classified as either 'financial assets' or 'financial liabilities at amortised cost'.

**Initial Recognition and Measurement**

Financial instruments are initially measured at fair value, when the related contractual rights or obligations exist. Subsequent to initial recognition these instruments are measured as set out below. Fair value represents the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

**Classification and Subsequent Measurement**

Financial instruments are subsequently measured at amortised cost using the effective interest rate method. The Association applies a simplified approach in calculating expected credit losses (ECL's) for financial assets held at amortised cost by recognising a loss allowance based on lifetime ECLs at each reporting date.

Amortised cost is calculated as:

- (i) the amount at which the financial asset or financial liability is measured at initial recognition;
- (ii) less principal repayments;
- (iii) plus or minus the cumulative amortisation of the difference, if any, between the amount initially recognised and the maturity amount calculated using the effective interest method; and
- (iv) less any reduction for impairment.

**Derecognition**

Financial assets are derecognised where the contractual rights to receipt of cash flows expires or the asset is transferred to another party whereby the Association no longer has any significant continuing involvement in the risks and benefits associated with the asset. Financial liabilities are derecognised where the related obligations are either discharged, cancelled or expired. The difference between the carrying value of the financial liability extinguished or transferred to another party and the fair value of consideration paid, including the transfer of non-cash assets or liabilities assumed is recognised in profit or loss.

**e) Impairment of Non-Financial Assets**

At each reporting date, the Association reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the statement of comprehensive income.

**f) Employee Benefits**

A provision is made for the Association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled. Employee benefits payable later than one year have been measured at the net present value of the estimated future cash flows to be made for those benefits. In determining the liability, consideration is given to employee wage increases and the probability that the employee may not satisfy vesting requirements. Those cash outflows are discounted using market yields on national government bonds with terms to maturity that match the expected timing of cash flows.

**g) Cash and Cash Equivalents**

Cash and cash equivalents include cash on hand and deposits held at call with banks with a maturity of three months or less.

**h) Revenue from Contracts with Customers**

Revenue from contracts with customers is recognised when control of the services are transferred to the customer at an amount that reflects the consideration to which the Association expects to be entitled in exchange for those services. The Association has generally concluded that it is the principal in its revenue arrangements because it typically controls the good or services before transferring them to the customer.

*Sale of Goods*

Revenue from sales of goods (including merchandise, equipment and final series ticket and canteen sales) comprises revenue earned from the sale of goods purchased for resale. Sales revenue is recognised when the control of goods passes to the customer which is at the time that the goods are physically transferred.

*Rendering of services*

Revenue from rendering of services (including sponsorships, nomination, playing, insurance and affiliation fees) is recognised over time, using an input method to measure progress towards complete satisfaction of the service, because the customer simultaneously receives and consumes the benefits provided by the Association.

**i) Grants and Subsidies**

Assets arising from grants and subsidies are recognised at their fair value when the asset is received or receivable. These assets are generally cash but maybe property which has been donated or sold to the Association at significantly below its fair value.

**j) Goods and Services Tax (GST)**

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

**k) Comparative Figures**

Where required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

**l) Trade and Other Payables**

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the Association during the reporting period. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

**m) Critical Accounting Estimates and Judgments**

The Committee Members' estimates and judgments, where appropriate, are incorporated into the financial statements based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the Association.

**n) Changes in Accounting Standards and Interpretations**

**New and amended standards and interpretations**

The new and amended Australian Accounting Standards and Interpretations that apply for the first time in 2025 do not materially impact the financial statements of the Association.

**Accounting Standards and Interpretations issued but not yet effective**

**AASB 18 Presentation and Disclosure in Financial Statements**

In April 2024, the AASB issued AASB 18, which replaces AASB 101 Presentation of Financial Statements. AASB 18 introduces new requirements for presentation within the statement of profit or loss, including specified totals and subtotals. Furthermore, entities are required to classify all income and expenses within the statement of profit and loss into one of five categories: operating, investing, financing, income taxes and discontinued operations, whereof the first three are new. It also requires disclosure of newly defined management-defined performance measures, subtotals of income and expenses, and includes new requirements for aggregation and disaggregation of financial information based on the identified 'roles' of the primary financial statements (PFS) and the notes. In addition, narrow-scope amendments have been made to AASB 107 Statement of Cash Flows, which include changing the starting point for determining cash flows from operations under the indirect method, from 'profit or loss' to 'operating profit or loss' and removing the optionality around classification of cash flows from dividends and interest. In addition, there are consequential amendments to several other standards. AASB 18, and the amendments to the other standards, is effective for reporting periods beginning on or after 1 January 2027, but earlier application is permitted and must be disclosed. AASB 18 will apply retrospectively. The Association is currently working to identify all impacts the amendments will have on the primary financial statements and notes to the financial statements.

## Independent auditor's report to the members of Canberra Region Junior Rugby League Incorporated

### Opinion

We have audited the financial report of Canberra Region Junior Rugby League Incorporated (the Association), which comprises the statement of financial position as at 31 October 2025, the statement of comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, notes to the financial statements, including material accounting policy information, and the statement by the members of the Committee.

In our opinion, the accompanying financial report presents fairly, in all material respects, the financial position of the Association as at 31 October 2025, and its financial performance and its cash flows for the year then ended in accordance with Australian Accounting Standards - Simplified Disclosures and the *Associations Incorporations Act 1991 (ACT)*.

### Basis for opinion

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the *Auditor's responsibilities for the audit of the financial report* section of our report. We are independent of the Association in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110 *Code of Ethics for Professional Accountants (including Independence Standards)* (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

### Information other than the financial report and auditor's report thereon

The committee members are responsible for the other information. The other information is the committee members' report accompanying the financial report.

Our opinion on the financial report does not cover the other information and accordingly we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial report, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial report or our knowledge obtained in the audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

### Responsibilities of the committee members for the financial report

The committee members of the Association are responsible for the preparation and fair presentation of the financial report in accordance with Australian Accounting Standards - Simplified Disclosures and the *Associations Incorporations Act 1991 (ACT)* and for such internal control as the committee members determine is necessary to enable the preparation and fair presentation of the financial report that is free from material misstatement, whether due to fraud or error.
