


2026 APPLICATION TO TRIAL PROCESS

STEP 1

Completion of Application Form

- The Team Manager or Coach is responsible for completing the Trial Match Application Form in full.
- All required details, including team information, opposition details, venue, and proposed date, must be included.

STEP 2

Submission to Club Secretary

- Once completed, the form must be sent to the Club Secretary for review and submission to the CRRL.

STEP 3

Submission to CRRL

- The Club Secretary will then complete the online sanction request through the CRRL system.
- A copy of the Trial Match Application Form must be attached to the online submission.

STEP 4

Approval Process

- Once submitted, the Canberra Region Rugby League (CRRL) will review the application and if necessary, seek sanction approval from NSWRL. This process may take up to 7-10 working days so the earlier you apply the better.
- The CRRL will contact the Club Secretary to confirm approval or to request any additional information.

PLEASE NOTE

Sanction Confirmation

- A trial match must not be conducted until official sanction approval has been received from the CRRL.

Team Lists

- Completed Team lists must be submitted to the CRRL via email by the Club Secretary/President no less than 48 hours prior to the trial match taking place.

Referees

- Clubs will be invoiced for the cost of referees for every sanctioned trial.

Application must be submitted to the Local League Administrator (LLA): -

2 weeks prior to departure date.

Overseas: *Expression of intention to tour 1 year.
Application 3 months prior to departure date.*
