Information on how to enter forms part of the terms and conditions of entry. Entry into the promotion is deemed acceptance of these terms and conditions.

a. WHO CAN ENTER

- a) To be eligible to enter Competition, you must:
 - i) Be aged 16 years or over;
 - ii) Be a resident of Australia.
- b) Employees of the Canberra Raiders, the Partner, their immediate families, and any associated agencies are ineligible to enter.
- c) Immediate family includes: spouse, de facto partner, child or stepchild, parent or stepparent, grandparent, uncle, aunt, niece, nephew, sibling, or first cousin.

b. HOW TO ENTER

- a) The Competition commences at Monday 25th August 9:00am AEST and ends at Sunday 7th September, 11:59pm AEST (the Competition Period).
- b) To enter, participants must:

- iii) Accept these Terms and Conditions;
- iv) Submit the completed form during the Competition Period.

c) Only one entry per person is permitted. No late, incomplete or illegible entries will be accepted.

c. PRIZE DRAW

- a) The draw will take place at Canberra Raiders Centre, 14 Torrens Street, Braddon, ACT 2612 on Monday 8th September, 2025.
- b) One (1) valid entry will be randomly drawn to win the prize. This is a game of chance.
- c) The winner will be notified via phone and in writing within two (2) business days of the draw.
- d) The winner's name may be published on Canberra Raiders and Partner social media or websites.

d. UNCLAIMED PRIZE

- a) If the winner cannot be contacted, a redraw will be conducted Monday 15th September, 2025 at the same location.
- b) The redrawn winner will be notified using the contact details provided.

e. PRIZE

- a) The prize consists of one (1) ESY Battery full supply and installation and one (1) \$250.00 Raiders Shop Gift Voucher.
- b) Prize is not exchangeable, transferable, or redeemable for cash. If unavailable, a substitute of equal or greater value may be provided.
- c) Any costs associated with accepting the prize are the sole responsibility of the winner.

f. ADDITIONAL PRIZE CONDITIONS

- a) The ESY Battery supply and installation is for a single residential dwelling. The dwelling must be located within the Australian Capital Territory or within a 50km radius from its border.





- b) The winner must be the legal owner of the dwelling or possess explicit written authority from the legal owner to permit the installation and any necessary modifications to the property.
- c) The dwelling must comply with all relevant provisions of the Building Code of Australia (BCA) for the safe and compliant installation of the battery. Renewables Warehouse reserves the right to decline installation if the property does not meet BCA standards or other safety requirements.
- d) The battery must be able to be located within 20 metres of the dwelling's Main Switchboard (MSB) as determined by Renewables Warehouse.
- e) The prize explicitly excludes the supply or installation of solar panels. It also excludes any costs associated with upgrading existing electrical infrastructure, switchboards, or other components of the dwelling that may be required to accommodate the new battery system. Such upgrades, if necessary, are the sole responsibility and cost of the winner.
- f) To be eligible for the battery installation component of the prize and the STC rebate, the winning dwelling must have a current solar Photovoltaic (PV) system installed, or the winner must facilitate the installation of a PV system concurrently with or prior to the battery installation. If these conditions are not met, the winner will only be eligible for the supply of the ESY Battery, at the discretion of Renewables Warehouse, and the installation component will be forfeited.
- g) The winner must assign all Small-scale Technology Certificates (STCs) generated by the battery installation to Renewables Warehouse or its nominated partners. This assignment is a condition of receiving the installation component of the prize.
- h) At the sole discretion of Renewables Warehouse, a "supply only" option for the ESY Battery may be offered to the winner as an alternative to the full supply and installation, particularly if the dwelling does not meet the installation requirements.

g. GENERAL

- a) The Promoter reserves the right to verify the validity of entries and to disqualify any entrant who tampers with the entry process.





- b) In the event of technical failure, fraud, or other causes beyond the Promoter's control, the Competition may be cancelled or modified.
- c) The Promoter's decision is final. No correspondence will be entered into.
- d) The Promoter accepts no liability for lost or delayed entries or any personal injury or loss arising from the Competition or use of the prize.
- e) Entrants are providing information to the Promoter and not to any social media platform used to promote the competition.
- f) These Terms and Conditions are governed by the laws of the Australian Capital Territory.
- g) The winner must comply with all terms of use of the prize.
- h) No portion of the prize is redeemable for cash, credit, or alternatives. No refunds or exchanges will be given.
- i) The Promoter accepts no responsibility for any variation in the value of the prize or for any tax implications.
- j) If an event beyond the Promoter's control prevents fulfilment of the Competition, the Promoter may cancel, suspend, or amend the Competition.
- k) The Promoter is not liable for any personal injury, damage, or loss suffered in connection with the prize or Competition.
- l) If there is a dispute as to the identity of an entrant, the Promoter reserves the right to determine the identity at its sole discretion.

- c) Site Inspection: Renewables Warehouse reserves the right to conduct a pre-installation site inspection of the winner's nominated dwelling to





assess its suitability for the battery installation. The prize is contingent upon a successful site inspection.

- d) **Permits and Approvals:** The winner is solely responsible for obtaining any necessary local council permits, approvals, or complying with any homeowner association rules that may be required for the battery installation. Renewables Warehouse will provide reasonable assistance with documentation but is not responsible for securing such approvals.
- e) **Dispute Resolution:** In the event of any dispute regarding the feasibility or conditions of the battery installation, the decision of Renewables Warehouse, acting reasonably, shall be final.
- f) **Warranty and Support:** The ESY Battery will be covered by the standard manufacturer's warranty. Renewables Warehouse will provide installation services in accordance with industry standards. Any ongoing maintenance or support beyond the initial installation and manufacturer's warranty is the responsibility of the winner.
